



MariaDB Software License Terms

These MariaDB Software License Terms (“**Terms**”) govern the Customer’s use of MariaDB proprietary software made available by MariaDB USA, Inc. or its affiliate (“**MariaDB**”) to Customer, including its Documentation, updates, and, if applicable, new versions (“**Software**”). “**Documentation**” means written technical information for the Software. By using Software, Customer agrees to these Terms. These Terms are in addition to, and supplement, the terms of a written agreement or MariaDB order form (the “**Agreement**”) between MariaDB and Customer, each as identified in the Agreement. Except as set forth herein, capitalized terms have the meanings set forth in the Agreement.

1. **License Grant.** Subject to Customer’s payment of the applicable fees as set forth in the Agreement, MariaDB grants to Customer a personal, limited, non-exclusive, non-transferable, worldwide, and revocable license, without the right to sublicense, to use Software for Customer’s internal business purposes and to use the Software’s documentation in support of Customer’s use of Software.

2. **License Restrictions.** Customer’s may only use Software during the applicable subscription term (“**Subscription Term**”) and only in combination with MariaDB products or services for which it has purchased subscription services from MariaDB or an authorized MariaDB partner. Customer has no right, and agrees not to:

(1) transfer, assign, resell, distribute, rent, lease, lend, or sublicense its license rights. Any attempt to do so is void. Customer shall not use Software with any MariaDB products or services for which it has not purchased subscription services,

(2) use Software in breach or excess of any limitations (e.g., quantities, a combination with other MariaDB products or services) prescribed by or agreed with MariaDB,

(3) use Software to perform services for third parties, whether on a service bureau or time-sharing basis, by way of managed services, commercial hosting services or similar environment, or otherwise, without the express written authorization of MariaDB,

(4) use Software to develop products or services competing with MariaDB products or services,

(5) use Software in any hazardous environment requiring fail-safe performance, where the failure of the Software could lead directly to death, personal injury, or severe physical or environmental damage,

(6) remove, conceal, or alter any Software identification, proprietary, copyright, intellectual property, or other notices in Software and Documentation,

(7) copy, decrypt, decompile, reverse engineer, disassemble, reduce to human-readable form, derive, or attempt to derive the source code of, algorithms, methods or techniques embodied in Software, or any updates or any part thereof, except to the extent expressly required by applicable law,

(8) modify, adapt, or create a derivative work of Software, or any updates or any part thereof, or

(9) assist or encourage any third party to do any of the foregoing.

3. **Proprietary Rights.** MariaDB owns all worldwide right, title and interest in Software and Documentation including all related copyright, trademarks, service marks, patents, trade secrets, know-how, moral rights, and all other proprietary rights, including registrations, applications, renewals and extensions of such rights existing anywhere in the world, whether registered or unregistered. Software is a trade secret of MariaDB and constitutes MariaDB confidential information. Except for the rights expressly granted in these Terms, MariaDB reserves all other rights in the Software and Documentation. Customer acquires no rights in the Software or Documentation other than those expressly specified in these Terms.

4. **Proprietary Notices.** Customer must reproduce all copyright and other proprietary notices on any copies of the Software, exactly as they appear on the original.

5. **Audit and Unauthorized Use.** Customer's use of Software is subject to audit rights and obligations set forth in the Agreement. Unauthorized use of the Software is a material breach of these Terms. Upon notice, Customer must promptly pay any applicable additional fees for such use. These fees will be calculated based on MariaDB's then-current list prices for the unauthorized use. A breach of the license restrictions will cause irreparable harm to MariaDB, entitling it to seek immediate injunctive relief in addition to any other available remedies.

6. **Benchmarking.** Customer must obtain MariaDB's prior written approval to disclose benchmarks or comparative tests or evaluations (each, a "**Benchmark**") of Software to any third party. Any approved disclosure of the Benchmark must be accompanied by a complete and accurate description of the testing environment and methodology, as stipulated by MariaDB.

7. **Term and Termination.** Upon termination or expiration of the Subscription Term, Customer must immediately stop using and, within ten (10) business days, destroy all copies of the Software and Documentation in its possession or under its control. If requested, Customer must certify this destruction in writing to MariaDB. All limitations of liability, disclaimers of warranty, and restrictions will survive termination of these Terms.

8. **FOSS.** These Terms do not apply to or change the license terms of any software that is subject to a free and open-source software (FOSS) license.

9. **Miscellaneous.** In case of conflict, the terms of the Agreement prevail over these Terms. If any portion of these Terms is found to be void or unenforceable, the remaining provisions of these Terms will remain in full force and effect. Except as expressly provided herein, these Terms, together with the Agreement, constitute the entire agreement between the parties with respect to the license of Software and Documentation.
